

NTE Official X (Twitter) Event Rules

Before participating in X (formerly Twitter) events (hereinafter referred to as "events") organized by Perfect World Games (Singapore) Pte. Ltd. (hereinafter referred to as "the Company"), please carefully read the following rules. Your participation on the official social media of NTE will be regarded as an agreement to abide by all event rules.

Eligibility

1. Participants must be of legal adult age as defined by the laws of their country or region of residence. Participants who are minors must obtain permission from a parent or legal guardian before participating.
2. Participants must meet the requirements specified in the official account's event posts.
3. Participants must not change their X (formerly Twitter) username during events, as this may prevent us from verifying accounts and delivering prizes.

How to Participate

1. Participation methods vary depending on the current event. Please refer to the official account's specific event post for details.
2. Participants' X accounts must be set to public during the event period. Participations from private or locked accounts will be regarded as invalid.
3. Participants must follow the official X (formerly Twitter) account (@NTE_GL) to participate. Unfollowing or deleting posts during the event period will invalidate their participation.
4. Each account may only win once per event.

Winner Notification

1. Winners will be notified via direct message (DM) on X (formerly Twitter). Notifications will only be sent to the selected winners and will not be publicly announced. Participants must ensure their accounts are set to receive DMs.
2. If a winner fails to respond within the specified period, the prize will be forfeited and may be awarded to another participant instead.
3. Winners cannot choose what type of prize they receive.
4. Winning rights are non-transferable.
5. All official community platforms and accounts share winners for the same event. There is no fixed number of winners for each region or platform, but it is determined by the actual number of participants from each region. An event is considered the same if the dates, content, prizes, and number of prize winners are identical.

Prize Distribution

Non-Physical Prizes:

Participants must claim their prizes within the period specified in the winner notification. Failing to do so will be regarded as forfeiting the prize.

Physical Prizes:

1. Please provide accurate shipping information within the period specified in the winner notification. Failing to do so will be regarded as forfeiting the prize.
2. Participants may be required to provide the following information for delivering prizes:
 - Full name, postal code, address, and phone number
 - Other information as needed
3. Prizes will not be redelivered if returned due to incorrect address, absence, or other delivery issues. In such cases, the prizes will be forfeited.
4. Prizes will be shipped within a designated period after contacting the winners. However, delays may occur.
5. Prizes will be delivered via a courier designated by the Company. The

shipping carrier cannot be specified.

6. The Company cannot respond to inquiries about shipping status or accommodate specific delivery date requests.

Important Notes

1. The use of multiple accounts by a single individual to participate in events is strictly prohibited. If such behavior is discovered, all participating entries will be regarded as invalid.

2. The right to participate is non-transferable and cannot be exchanged for cash.

3. Any fraudulent behaviors, false declarations, impersonations, or actions that disrupt the fairness of events are prohibited.

4. Acts that infringe on the rights of others, defame others, or violate public order and morals are strictly prohibited.

5. If any illegal behaviors are discovered during events, legal action may be taken.

Disclaimer

1. Participants bear full responsibility for their participation and any consequences that arise, including the receipt and use of prizes.

2. All submitted content must be created by the participant or used with permission. The Company accepts no responsibility for any disputes regarding copyrights, portrait rights, trademarks, patents, or any other usage rights.

3. In the event of a malfunction, error, or policy change on X (formerly Twitter) that prevents events from proceeding as planned, the Company reserves the right to interrupt, modify, or terminate events without giving prior notice. In this case, the Company will not be liable for any damages resulting from such actions.

4. The Company will not be responsible for any issues caused by the

participant's network environment or device.

Handling of Personal Information

1. The personal information of winners (such as names, addresses, phone numbers, etc.) will only be used for delivering prizes and related communications for events.
2. The personal information provided by winners may be shared with third-party contractors as necessary for delivering prizes.
3. The Company will manage participants' personal information appropriately and will not disclose or provide it to any third party without prior consent. Contractors will handle the information as required for events and will promptly delete or destroy it after the events end.
